### VINYL LINEAL EXTRUSIONS LIMITED WARRANTY

Chelsea Building Products, the designer and extruder of the rigid vinyl PVC frame and accessory components used in the production of windows and doors, manufactures to the highest standards of design engineering and product performance. Our warranty is backed by years of proven performance in the field and by the sale of millions of vinyl windows and doors using our lineal extrusions.

#### WARRANTY COVERAGE

Chelsea Building Products warrants that their rigid vinyl PVC (polyvinyl chloride) lineal extrusions as originally sold to its customer will be free from manufacturing defects that could cause the product to splinter, flake, peel, blister, decay, rot, or corrode for a period of twenty-five (25) years.

Chelsea Building Products PVC profiles are produced using the finest, exterior grade weatherable material.

#### COVERAGE EXCLUSIONS AND LIMITATIONS

Chelsea Building Products shall not be liable for, and this warranty does not apply to, any failure, defects or damage resulting from or in connection with misuse, neglect or improper storage, improper application or application not in adherence to normal industry standards. In addition, Chelsea Building Products shall not be liable for damage incurred from impact of foreign objects, vandalism, riot, civil disorder, misuse, abuse, harmful fumes, vapors or chemical pollutants, fire, hurricane, tornado or other violent storms or casualty or act of God, defects or failure to install properly, building settlement, structural failure of walls or foundations, shifting of product or structure after installed, exposure to harmful chemicals, building heat, excessive temperature exposure, airborne stains, mildew or pollutants or any other causes or occurrences beyond the control of Chelsea Building Products.

Exposure to sunlight, air pollutants and other normal atmospheric conditions may cause a uniform variation in the color of the vinyl lineal, given that normal weathering will cause changes to any surface.

#### REMEDIES

This warranty applies to products produced by Chelsea Building Products and sold to its customer for its intended use. Any claim or remedies, if the product is believed to be defective under the terms of this warranty, are between Chelsea Building Products and its original customer. Any claims or defects under this warranty must be submitted in writing by the original extrusion purchaser to Chelsea Building Products, promptly after discovering the defect claimed, including the date the product was produced, the location of the defective material and a description of the defect.

If the material is determined to be defective due to the manufacturing of the product, Chelsea Building Products will, at its option, either (1) to the original cost of the lineal extrusions or (2) to the replacement of the defective material and return transportation costs, but not for consequential damages, including, but not limited to, costs incurred in the fabrication of the extrusions into finished windows or installation of said finished windows into buildings or structures.

Chelsea Building Products reserves the right to discontinue or change any vinyl window or door lineal extrusion. If such vinyl window or door extrusion has been discontinued or is not available, Chelsea Building Products reserves the right to substitute such vinyl window or door extrusion of equal quality as may be compatible.
